To All Adult Ski Racing Enthusiasts:

It is happening, come be a part of the Towne Challenge at Mt. Holiday. This group continues to offer a fresh, hip twist on what we all have grown to love in downhill ski racing, maximizing a relaxed but competitive environment so as to ensure total participation by interested skiing enthusiasts. Check out the flexible - for everyone format, cool scoring and great LOCAL skiing gem, get out of the house and ride. WHOOP WHOOP!

**Who:** All area ski/snowboard/tele riders who have the need for speed, or just a good time and a reason to get out of the house while supporting the local ski hill. Registration closes when there are 75 participants total signed up and will be on a first come first served basis. Registration deadline is January 10th, 2019. Must be 21 or older to compete.

**When: Wednesdays**, first “practice” race will be held Jan 9<sup>th</sup>, 2019 and regular season races will begin the following Wednesday and end Feb 27<sup>th</sup>, 2019.

**Format:** To accommodate all of your busy schedules we will follow an extremely relaxed format. There will be no run orders and all participants can show up to get there 2 runs at their convenience. The only expectation is that all runs be finished by 8pm (or sooner depending upon the number of participants on a given night. All scores will be the combination of each participant’s first two runs in the course each evening. Sorry, no practice runs.

**Scoring:** Points given in each race will be equivalent to the finishing place of each participant. All DNF/ DQ will be scored in accordance with the FIS penalty which is the number of racers in the field +1. All DNS (no shows) shall be the total of racers plus 5. There will be 7 races from which the worst 2 results will be dropped for the overall scoring.

**NO SPEED SUITS ALLOWED.** An extra penalty of 50 points shall be assessed to any participant sporting lycra or any other similar fabric with nothing covering it!

**Registration / Fees:** Print, fill out and sign attached registration form and Liability Waiver and send to Mt Holiday, 3100 Holiday Road, TC 49686 with check for \$50 made out to MT. HOLIDAY. **There will be \$12 tickets on Race night for those who do not have a season pass.**

**Adult Race League Participant  
Acknowledgement, Consent and Release**

1. Registrants enrolled in the Mt. Holiday Adult Race League, hereinafter referred to as owner. The registrant is subject to the rules and regulations determined by the owner & its agents.
2. The Registrant acknowledges the inherent risks and dangers and my responsibility to satisfy myself as to the conditions surrounding the ski program and in consideration of and as a condition precedent to my participation in this program, I hereby unconditionally release the Mt. Holiday, Inc. and its personnel, and any person connected with or involved in producing this program, from all liability and hereby waive any claims that I may now have or which may arise as a result of my participation in this program.
3. The Registrant covenants not to sue and releases the owner, and any other sponsors or agents, from any liability arising out of personal injury wherein the personal injury was the result of an activity conducted as part of the usual activity of the owner. The owner assumes no responsibility for activities undertaken by the Registrant without proper supervision and guidance.
4. The Registrant agrees that in the event of a claim being made against the owner for personal injury that notice of said claim is made to the owner by Registered mail within 90 days of said personal injury. Failure on the part of the Registrant to deliver said notice shall constitute a waiver of the Registrant's right to sue under the laws of the State of Michigan or any other jurisdiction.
5. The Registrant acknowledges that the provisions of this Acknowledgement, Consent, and Release shall be binding upon the Registrant, his heirs, executors, administrators and assigns, and shall be governed by the laws of the State of Michigan. The Registrant agrees that any suit or legal action shall be brought only in the State of Michigan and that the terms of this document shall be admissible in evidence as a binding legal agreement between the Registrant and the owner. The Registrant acknowledges that if a Court determines that part of this document is inadmissible that the remaining paragraphs shall remain in full force and effect.
