PLEASE READ CAREFULLY BEFORE SIGNING ON REVERSE SIDE

I understand that the ski-binding-boot system will not release at all time or under all circumstances where the release may prevent injury to any part of the skier's body, nor is it possible to predict every situation in which it will release, and it is therefore no guarantee of safety to any portion of my body.
3. I have received instructions in the use of this equipment and have received satisfactory answers to any questions I may have regarding the use and function of this equipment. If I feel the equipment is not functioning properly, I will stop using it and have it inspected, repaired, or adjusted by a qualified technician.
4. To the fullest extent allowed by law, I hereby agree to RELEASE, IDEMNIFY, and HOLD HARMLESS the ski shop and all manufacturers/distributors of this equipment and their owners, agents, and employees from any and all liability for damage, injury, or death to myself or any person or property which may result while using any legal claim or suit against these persons, whether based upon negligence, breach of warranty, strict products liability or ANY other legal theories.
5. I accept this equipment AS IS and without any warranties, express or otherwise.

This document is a legally binding contract, superseding any other agreements or representations by or between the parties and which is intended to provide a comprehensive and complete Release of Liability, but it is not intended to assert any claims or defenses which are prohibited by law.
